BACKGROUND AND LIST OF EXHIBITS

The following is a list of the defendants and the verbatim postings coinciding with Exhibits A and B and proof of violations indicated as per law. Exhibit C is an email from John Paul denying me my first Amendment rights because I said something he didn't like.

The conduct of all the listed defendants was more than negligent, their conduct was willful and they acted with actual malice and had malicious intent.
