ON THE ABOVE DATE AND TIME THIS OFFICER WAS DISPATCHED AT 21 FOR A CURT LARRICK, BEAVER COUNTY SHERIFF DEPUTY.

THIS OFFICER CALLED MR. LARRICK AND LARRICK STATED THAT HE WAS AT THE STATE STREET ELEMENTARY SCHOOL WHERE HIS SON, [REDACTED] ATTENDS. LARRICK STATED THAT WHILE HE WAS AT WORK HE RECEIVED A PHONE CALL FROM HIS SON'S SCHOOL TEACHER STATING THAT HIS WIFE, KRISTA MICHAELS, WAS AT THE SCHOOL ATTEMPTING TO TAKE [REDACTED] AND SHE WOULD NOT DISCLOSE WHERE SHE WAS TAKING HIM TO.

UPON ARRIVAL TO THE SCHOOL I MET WITH DEPUTY LARRICK AND HIS SON WHO HAD ALREADY BEEN RELEASED BY THE SCHOOL TO LARRICK. LARRICK STATED THAT HE AND HIS WIFE ARE SEPARATED AND A DIVORCE IS PENDING. LARRICK STATED THAT HIS WIFE HAS BEEN CALLING HIS CELL PHONE MAKING THREATS TOWARDS HIM AND HIS JOB. LARRICK THEN PLAYED THE VOICE MAIL MESSAGE FROM HIS CELL PHONE FOR ME TO HEAR.

AFTER SPEAKING TO MR. LARRICK THIS OFFICER THEN WENT TO SPEAK WITH KRISTA MICHAELS WHO WAS IN THE FRONT OFFICE OF THE SCHOOL. MS. MICHAELS WAS VISIBLY ANGRY AND UPSET. THIS OFFICER THEN ASKED MS. MICHAELS WHY SHE WAS ATTEMPTING TO TAKE HER SON FROM THE SCHOOL WITHOUT CONTACTING HIS FATHER OR THE SCHOOL WITH PRIOR NOTICE. MS. MICHAELS ANSWERED "BECAUSE HE'S MY SON AND I'M ALLOWED TO TAKE HIM". THIS OFFICER THEN TOLD MS. MICHAELS THAT SINCE THERE WAS NO CUSTODY AGREEMENT IN PLACE YET BETWEEN HER AND MR. LARRICK AND THAT [REDACTED] WAS CURRENTLY LIVING WITH MR. LARRICK THAT SHE WOULD HAVE TO SPEAK TO A JUDGE TO GET AN AGREEMENT WORKED OUT. AT THIS POINT MS. MICHAELS BECAME IRATE AND VERY UNCOOPERATIVE AND GOT IN HER VEHICLE AND DROVE OFF.

MR. LARRICK REQUESTED THAT THIS OFFICER SPEAK TO HIS SON'S DAY CARE A ROBERT AND JERRY SCHULTZ AT 261 BERRY STREET. UPON ARRIVAL AT THE DAY CARE THIS OFFICER WAS MET BY BOTH ROBERT AND JERRY SCHULTZ AND I ASKED THEM IF MR. LARRICK'S SON [REDACTED] CAME TO THERE DAY CARE AND THEY SAID YES HE DOES. THEY ADVISED ME THAT [REDACTED] HAS BEEN LIVING WITH HIS FATHER FOR ABOUT A YEAR NOW. MRS. SCHULTZ ALSO ADVISED THIS OFFICER THAT MS. MICHAELS HAS MADE ALLEGATIONS AGAINST THE DAY CARE CENTER THAT THEY WOULD NOT LET HER SPEAK TO HER SON. MRS. SCHULTZ ADVISED ME THAT WAS NOT TRUE AND THAT SHE HAS NEVER CALLED TO SPEAK TO [REDACTED]
